The purposes of the Santa Susana Mountain Park Association are the protection, preservation, restoration, and enhancement of the Santa Susana Mountains and Simi Hills as open space lands and wildlife corridors linking the Los Padres National Forest and San Gabriel Mountains, including the Angeles National Forest, to the Santa Monica Mountains; as habitats for plants and animals native to the Santa Susana Mountains and the Simi Hills; as locales of unique geologic formations; as sites of ethnological, archaeological and historical interests; to provide passive recreational opportunities and environmental education opportunities; and, to support the acquisition of new public parks, open space and conservation easements, the expansion of existing parks, participate in the planning of park infrastructure and programs, and support said programs.

The Basics on HOW TO TRACK LEGISLATION By Diana Dixon-Davis

Anybody, anywhere with internet access can now track California legislation. If you know the bill's number, topic, or author, you can begin to follow that bill from introduction, through committee hearings, staff reports, amendments, committee votes and finally to the governor's desk. The legislature has put all this information, on line, and in a timely manner. By registering your e-mail address anyone can also "subscribe" to a bill. Every time there is any "action" on the bill/bills of interest you are notified by e-mail.

To get started, go to the <u>California State Home Page</u> and midway down on the left hand side, click on <Legislature.> On the next page, click on <Bill Information>, and the on the next page click on <Bill Search>. By Bookmarking Bill Search, you can go directly to that page the next time you want to look up a bill. Enter the bill number, and other information (legislative session) and the appropriate bill will be called up. Note that all current and past bills (since 1993) are available on line. Upon retrieving a bill you can check its <u>Status</u> (current disposition), <u>History</u> (status since introduced), <u>Committee Reports</u>, all votes and amendments, All bills follow a pattern of introduction, hearings and floor votes set up by the annually adopted calendar and rules.

To get more information about the legislative process go to the <Publications> link available on most legislature pages, and access either the <u>Legislative Primer</u> or the <u>Glossary</u>. Between the two documents you can get many technical questions answered. If you are stumped, you can call me or your local legislators' offices. There are many ways to "game" the system, from straight forward Hijacking a bill, Gut and Amend, to complex insider "deals." Bills can change completely from one day to the next, a single word change can totally alter its meaning. Be careful when following or supporting a bill to always identify the "day/ version" you are referencing!

State Susana Pass State Historic Park

On February 29, 2008, the State Park & Recreation Commission met and approved the general plan for the Santa Susana Pass State Historic Park. The community has long been waiting for implementation of the plan creating the general framework for operation of this historic and treasured site.

The plan provides for primary access to the park from Chatsworth Park South, at the west end of Devonshire. Secondary access points under the plan are from Lilac Lane, Andora Avenue near Lassen, Jeffrey Mark Court in the Rockpointe Condominiums and from Santa Susana Pass Road.

Hiking, equestrian and bike trails provide good access to the major areas of the park, aithough the number of trails is greatly reduced to improve preservation and reduce human impacts. Trail access points, to Eagles Nest on the south, toward the southwest corner of the park, toward the high mesa to the west, are included. Access to Simi Valley to the west, on existing trails that go to Corriganville, are preserved. Camping has been approved near Santa Susana Pass Road. The secondary access points may include small parking lots and restrooms.

Based on public concerns, equestrian staging areas are to be improved and it was clarified that parking areas would be off-street on park land.



Tests confirm high lead levels at Chatsworth Park South

CHATSWORTH -

One-third of the soil tested last month at the shuttered Chats-worth Park South contains enough lead to exceed state standards for home and child play areas, according to a report.

The city closed the 80-acre park Feb. 14 after state toxic regulators warned of a positive test for lead at a former skeet range there.

An environmental consultant hired by the city found that one-third of the samples it took from the park two weeks ago contained lead at or exceeding health standards.

"If a child were to get that soil in their system, by putting it in their mouth ... it could have adverse health effects," said Paul Davis, environmental specialist for the Department of Recreation and Parks.

"Which means we need to take note and do something about it."

The consultant, California Environmental of Camarillo, found lead in 23 of 66 soil samples at or exceeding 150 milligrams per kilogram in 23 of 66 samples - the limit set by the California Environmental Protection Agency for residential and children's play areas.

The samples - taken from 4 inches to 1 foot deep on a grassy glade on the site of a former gun and skeet range up against the Santa Susana Mountains - tested positive for lead, Davis said. More lead was found in a drainage ditch in the park.


On Friday, the state Department of Toxic Substances Control, which will oversee potential park cleanup, requested that the city take more tests.

"We continue to have the health and safety of our park users as our first concern and will immediately start the additional testing," said parks General Manager Jon Kirk Mukri in a statement.

Testing will begin Monday north of the park community center at 22360 Devonshire St. Results are expected the following week.

City officials said they hope to fence off contaminated areas and soon reopen clean portions of the park. Plans for the park will be announced when soil tests are completed.

"The main intent is to get those areas permanently restricted so the public is protected in every way," Davis said.
